Quality Control Management

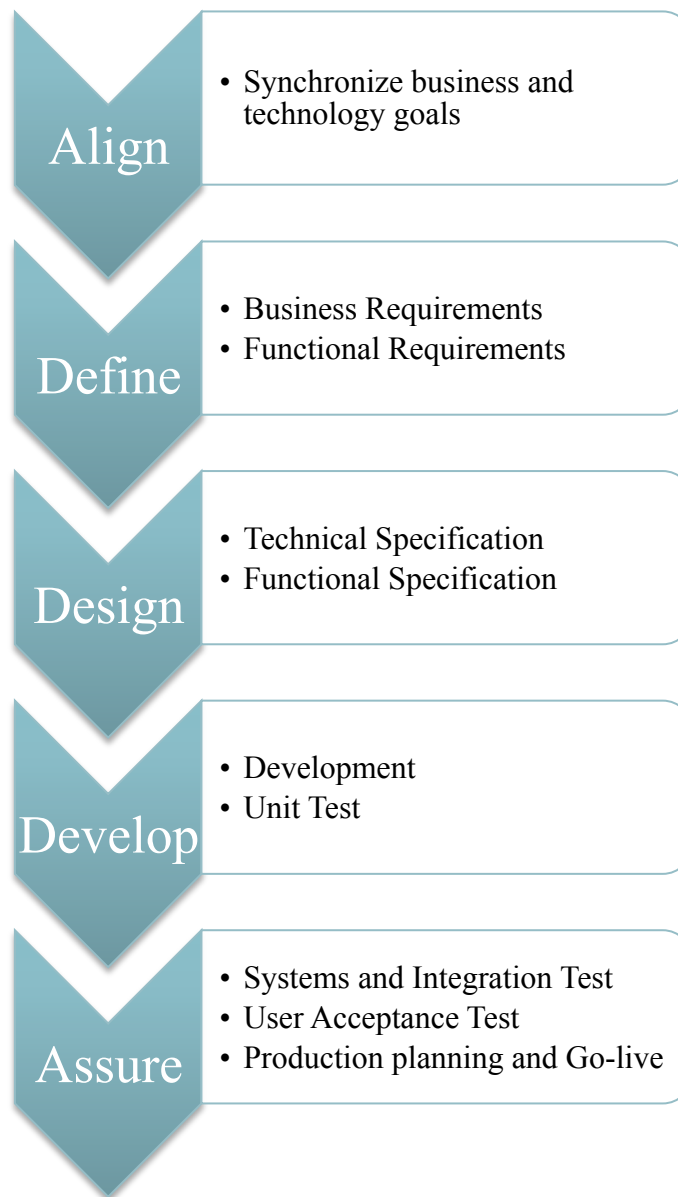
- Junction Partners Quality Control (QC) plan addresses measurement, assessment, management, and reporting techniques, and the means of conducting periodic and event-driven Quality Assurance (QA) Reviews.
- Junction Partners is committed to establishing a Quality Assurance (QA) capability on projects that will provide the client and its end users with a supporting project team built upon industry best practices. Our QC plan ensures our adherence to metrics, standards, and plans, which allow clients to track Junction Partners project performance. The QC Plan includes proposed surveillance methods and a schedule that will serve as the basis for developing the final QC plan after contract award.
- Junction Partners shall establish and maintain a system that tracks the status and progress of client-identified and contractor-identified, system-wide quality issues, and provides reports to the client. This system will identify problems by severity, area of responsibility, assignment for solution, proposed solution, due date, and summary status (e.g. Open, Closed, Deferred, Being Implemented, etc.)
- A management committee consisting of the client QA Point of Contact (POC), and Junction Partners QA Manager and Project Manager will review the problem reports. This committee shall make decisions relating to the disposition of quality problems, and is responsible for providing client with a monthly summary of problem status
- A well-defined set of Standard Operating Procedures (SOP) is the basis for managing and delivering high-quality services. The QA Manager will develop a QA SOP manual, which will outline for all project team members the expected quality levels for all project activities. Each Team Lead will be responsible for incorporating the applicable elements of the QA SOP into the individual SOP for his/her team's area of support. The QA Manager will ensure that all project staff members are trained in the appropriate QA policies and procedures, and will routinely examine each SOP for completeness, effectiveness, and implementation of all changes/improvements.

- If Junction Partners uses subcontractors, they will be expected to adhere to the same quality controls standards and processes employed by Junction Partners without exception.
